NOTIFICATION

WHEREAS the State Government, in exercise of the power conferred by section 8 of the West Bengal Municipal Act, 1993 (West Ben Act XXII of 1993) has determined by notification No. 479/C-4/MIM-9/94 dated the 26.9.94 read ~~with Order No. 536/C-4/MIM-9/94 dt. 21.11.94~~ that the number of wards in the Municipal area of the ~~Mamari Notified Area Authority~~ Municipality in the district of Burdwan hereinafter ity referred to as the said area shall be sixteen.

NOW THEREFORE, in exercise of the power conferred by section 3 of the West Bengal Municipal Elections Act, 1994 (West Ben Act XXXIV of 1994) and in supersession of all previous notifications in this behalf, the West Bengal State Election Commission, having regard to population, dwelling pattern, geographical conditions and economic considerations and after consideration of the views of the Municipality as aforesaid for the said area hereby divides the said area into the required sixteen wards as described in the Table below for the purpose of election of members of the Municipality as aforesaid for the said area.

WARD NO. I

- North : From Chakdighi More towards easternside along via new G.T. Road upto Baghila Mouza and the connection of G.T. Road and in the right-end side.
- East : From the Baghila Mouza and the connection of G.T. Road upto along D.V.C. Canal and towards the Baghila Mouza connection in the rightend side.
- South : From the connection of D.V.C. Canal and Baghila to towards Western side along Canal Bundh and upto the connection of Kharo Road rightend side.
- West : From the connection of Canal Bundh and Kharo Road towards north along Kharo D.V.C. Para Road and the Road of Nanoor Garden via Kalitala and Jamalpur Road upto the More of Chakdighi in the rightend side.

WARD NO. II

- North : From Uday Palli along towards the easternside via Jamalpur Road upto D.V.C. Agriculture Office More in the rightend side.
- East :

- East** : From D.V.C. Agricultural Office More upto the D.V.C. Canal and the connection of Kharo Road in the rightend side via D.V.C. Para Link Road and via D.V.C. Para Kharo Road.
- South** : From the connection of Kharo Road and Canal Bundh along towards West along the Jamalpur Road & D.V.C. Canal connection upto Udaypalli in the rightend side.
- West** : Udaypalli, D.V.C. Canal.

WARD NO. III

- North** : From the connection of Tatarpur Mouza and Railway Line along the eastern side towards New G.T. Road Railway line upto the crossing of rightend side.
- East** : From new G.T. Road and Rly. crossing via G.T. Road and the connection of Sultanpur Road via Sultanpur Gram Rastha along towards south upto Sultanpur More in the rightend side.
- South** : From Sultanpur More upto Udaypalli in the rightend side via Jamalpur Road toward South-West.
- West** : From Udaypalli upto Northern side along the connection of Tatarpur Mouza and Rly. line in the rightend side via Memary Municipality boundary in the North.

WARD IV

- North** : From the connection of Sultanpur Road and new G.T. Road in the east along upto Chakdighi More in the right side.
- East** : From Chakdighi More upto Kharo Road & D.V.C. Road junction.
- South** : From Chakdighi More upto Sultanpur More in the right via Kalitala, via, D.V.C. Para, Nanoor Bagan Road & the connection of Link Road via Agricultural Office More.
- West** : From Sultanpur More towards Northern side along to Sultanpur Road upto new G.T. Road connection in the rightend side of the boundary.

WARD V

- North** : From new G.T. Road Rly. Gate along the railway line towards east along upto Bazar Rail Gate in the right side.

- East : From Bazar Rail Gate crossing via east-southern G.T. Road along upto the new G.T. Road connection in the right side.
- South : From the connection of Old & New G.T. Road upto along G.T. Road via G.T. Road in the Western side towards new G.T. Road in the right side.
- West : Boundary of Ward No.3.

WARD NO.VI

- North : From the crossing of Bazar Rail Gate towards Rail line along upto the Mouza and railway line connection in the right side.
- East : From the crossing of Bagila mouza and Railway line towards southern side along upto the connection of G.T. Road & Baghila mouza in the right side.
- South : From the connection of Bagila Mouza and G.T. Road towards western side along via G.T. Road and old G.T. Road upto Bazar Railway Gate in the rightend side.
- West : From the connection of old and new G.T. Road upto Bazar crossing.

WARD NO.VII

- North : From Bamanpara More towards Station Road in the east, old Telephone Exchange Road, old Post Office Para Road, old Monteswar Road and via Duttapara Rd. upto Nagapara Road in the rightend side.
- East : From Nagapara More to towards southern side along via Ilampur and Kuspukur Road upto Rly. line connection.
- South : From the connection of Kuspukur Road and Rly. line and along Rly. line towards western side upto along Chanapatti Road and Rly. line crossing in the right side.
- West : From Chamapatti Road and Rly. line crossing along Chanapatti Road in the north upto Bamanpara More in the rightend side.

WARD NO.VIII

- North : From the connection of new Manteswar Road upto Hospital more in the right side via new Manteswar Road along towards eastern side.
- East : From Hospital More via old Manteswar Road towards south to V.M. School, Unit-1 and from V.M. School to

- East(contd): V.M. School to via Kalitala Road and after crossing Magherpara Gangur Canal culvert upto Nagapara More in the rightend side.
- South : From Naghapara More along towards western side to Duttapara Road, via old Monteswar Road and Old Post Office Para Road upto Dulepara More in the right side.
- West : From Delepara More upto new Monteswar Road's connection towards north in the rightend side.

WARD NO.IX

- North : From the connection in between Majherpara Road and Gangur Canal culvert upto along Gangur Canal in the West along upto Baghila Mouza and the connection of D.V.C. Canal in the rightend side.
- East : From the connection of Baghila Mouza and D.V.C. Canal towards south along via Municipal boundary via Rly. line and Baghila Mouza in rightend side.
- South : From Baghila mouza and in between the connection of Rly. line towards along the Rly. line east upto Kusspukur and Rly. line connection in ritht side.
- West : From Kusspukur Road and Rly. line connection towards north along via Naghapara More, via Majherpara Road and Gangur Canal culvert in the rightend side.

WARD NO.X

- North : From Hospital More towards Monteswar Road in the east along upto Chaktipara end of the Municipal boundary in the rightend side.
- East : From the end of the Municipal Boundary Chaktipara upto Baghila mouza and D.V.C. Canal connection towards south in the rightend side.
- South : From the connection of D.V.C. Canal and Bagila mouza via towards D.V.C. Canal and Gangur towards western side along upto the rightend side of Majherpara Rd.'s culvert.
- West : From Magherpara Road and Gangur culvert via Kalitala para Road via V.M. school, Unit-1 upto the edge adjacent to Hospital More of Old Monteswar Road in the rightend side.

WARD NO.XI

- North : Starting from culvert of Someshpur Road near B.D.O. Office to Pirpukur towards east, along Someshpur Rd. and upto D.V.C. Canel along Pirpukur Road. Then along Canel Bundh to Kadampukur culvert towards right and side.
- East : Starting from Kadampukur culvert upto Hospital More towards right hand side along Monteswar Road, towards south.
- South : Starting from Hospital More upto old Gangur Canel culvert towards right near Mayer Kolepara along new Monteswar Road towards west.
- West : Starting from Gangur culvert near Mayer Kolepara upto culvert of Someshpur Road towards right near B.D.O. Office towards north along Gangur Canel.

WARD NO.XII

- North : Starting from the junction of Golapmani Road and Someshpur Road upto the culvert of Manteswar Road (Towards right) via the culvert of Someshpur Road and along old Gangur Canal (towards east)
- East : Starting from the culvert of Gangur Canel of Manteswar Road near Mayer Kolapara upto Dulepara More (towards South).
- South : Starting from the junction of Station Road upto Bamanpara More (right-hand side) along Station Road (towards West).
- West : Starting from Bamanpara More upto the junction of Someshpur Road and Gopalmani Road (towards right hand side) along Gopalmani Road (towards North).

WARD NO. XIII

- North : Starting from the extreme corner of the Municipality Office by the side of G.T.Road to Dighirpar Ambagan along the Power House Road, then upto the junction of Gopalmani Road via Dighirpar Road and Primary School Road of Dakshin Radhakantapur.
- East : Starting from the junction of Gopalmani Road and Dakshin Radhakantapur Primary School Road upto the Railway junction(right hand side) via Bamanpara More (towards South) and along Chhanapatti Road.

WARD NO. XIII

- South : Starting from the junction of Chhanapatti Road and Railway line upto the extreme corner of the Municipality (Right hand side) along Railway line (towards west).
- West : Starting from the Railway line from the extreme end of the Municipality upto G.T.Road (Right side) along the extreme end of the Municipality (towards North)

WARD NO. XIV

- North : Starting from the Bridge on the Golapmoni Road over canal upto the Boundary line of Dakshin Radhakanta pur Mouza along the canal.
- East : Starting from the office of the Assistant Engineer (on the Gopalmani Road) upto the D.V.C. Canal Bridge (towards North).
- South : From Gopalmoni Road to the Boundary line of Gopinathpur along the Kacha Road and along towards east par and North Par of the Dighi (towards West).
- West : From and along the Municipal Boundary line adjacent to Sub-Station of Mouza Gopinathpur to the Boundary line of Dakshin Radhakantapur Mouza (towards North) that coincide with the canal.

WARD NO. XV

- North : Starting from the extreme end of the Municipality on the Gopalmoni Road upto Chakraborty Para (at the extreme end of Municipality on Manteswar Road) along the Boundary line of Merua Mouza and Durgadanga Mouza.
- East : Starting from the Chakraborty Para (which is at the extreme end of the municipality) upto the culvert of Kadampukur along Manteswar Road (towards South).
- South : Starting from the Kadampukur Culvert upto the extreme end of the Municipality along the North Bandh of the Canal and along the Boundary line of Mouza Dakshin Radhakantapur (towards West).
- West : Starting from the junction of end of the Boundary line of Dakshin Radhakantapur Mouza and Canal upto the end of the Boundary line (towards North) of the Municipality, along the Boundary line of Dakshin Radhakantapur Mouza (towards North).

WARD NO. XVI

- North : Starting from D.V.C. Canal Bridge upto the junction of D.V.C. Canal Bandh and Pirpukur Road, along the Dakshin Par of the Canal.
- East : Starting from the junction of D.V.C. Canal Bandh and Pirpukur Road upto the junction of Someshpur Road (along the South).
- South : Starting from the junction of Pirpukur Road and Someshpur Road upto the junction of Gopalmoni Road, along the Someshpur Road (towards West).
- West : Starting from the junction of Gopalmoni Road and Someshpur Road upto D.V.C. Bridge (Right) along Gopalmoni Road (towards North).


